

## **Nomination Committee**

The Nomination Committee proposes the Nomination Committee to consist of five members and proposes re-election of Jan Åke Jonsson, Andrea Fessler and Aage Figenschou and the election of Carina Andersson and Victoria Skoglund as new members for the period until the next Annual General Meeting. Victoria Skoglund is proposed as Chairman of the Nomination Committee. If a member of the Nomination Committee should leave the Nomination Committee before its work is concluded, the Chairman of the Nomination Committee shall be given the assignment to contact the largest shareholder that has not already appointed a member of the Nomination Committee and to ask that shareholder to appoint a member to the Nomination Committee. If that shareholder does not wish to appoint a member to the Nomination Committee, the second largest shareholder will be asked to do so, and so on.
